Sub: NTA Declares the Final NTA Scores for Joint Entrance Examination (Main) - 2024 for Paper 2A (B.Arch.) and Paper 2B (B. Planning) – Reg.

The National Testing Agency has conducted the Joint Entrance Examination (Main) – 2024 **Paper 2A (B.Arch.) and Paper 2B (B.Planning)** in two Sessions in **Computer Based Test (CBT) mode** as per the following schedule:-

Session	Paper	Exam date
Session 1	Paper 2A (B.Arch.) and Paper 2B (B.Planning)	24 January 2024
Session 2	Paper 2A (B.Arch.) and Paper 2B (B.Planning)	12 April 2024

Paper 2 of the JEE (Main) - 2024 were conducted as per the following details:-

- B. Arch. (Paper 2A): Mathematics-(Part I) and Aptitude Test-(Part II) in “Computer Based Test (CBT)” mode and Drawing Test –(Part III) in “Pen & Paper” (offline) mode.*
- B. Planning(Paper 2B): Mathematics-(Part I), Aptitude Test-(Part II), and Planning (Part III) in “Computer Based Test (CBT)” mode.*

The Examination was conducted in **13 languages (Assamese, Bengali, English, Gujarati, Hindi, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu, and Urdu).**

The Examination was conducted at **421 examination centres in 299 Cities in Session 1** and **420 examination centres in 291 Cities in Session 2** [including **17 cities** outside India in **Manama, Doha, Dubai, Kathmandu, Muscat, Riyadh, Sharjah, Singapore, Kuwait City, Kuala Lumpur, Lagos/ Abuja, Colombo, Jakarta, Vienna, Moscow, Port Louis, and Bangkok**].

The Examination was monitored in the following ways: -

- The Central Control Room was opened to monitor and facilitate the smooth conduct of the Examination on the ground. **02** National Coordinators, **18** Regional Coordinators, **291** City Coordinators, and approx. **583** Observers were positioned.
- Live CCTV Surveillance was planned in all examination centres to curb malpractices in the examination. The NTA also made arrangements for live viewing of remote locations of all examination centres from the Control Room located in the NTA premises of New Delhi. Recording of CCTV Systems was also done.
- The examination centres were also monitored using AI-based Video Analytics and virtual observers.
- In order to stop cheating using mobile networks, Jammers were installed in all the Centres.
- Candidates were given an opportunity for both Sessions to see their responses to the Question Papers and to challenge the Answer Keys. The Final Answer Keys of Paper 2 have also been displayed for both sessions on the JEE (Main) website: <https://jeemain.nta.ac.in>
